Scope of the Opioid Crisis in New York

- Over 2000 people lost their lives to opioidrelated overdoses in NYS in 2015 alone.
- NYS has seen an astounding 71% increase in deaths from drug overdoses and chronic drug use between 2010 and 2015.





New York is Being Affected by Opioids and Fentanyl More Intensely Than Most States

New York's opioid overdose rate has increased for the past 6 years and is higher than the U.S. average.

Opioid-related hospitalization rate is **60% higher** than the national rate. Opioid-related hospitalization rates are high in New York

Emergency Room Visits Due to Opioids Continue to Increase Each Year

Opioid-related emergency room visits in New York have doubled between 2005 and 2014.

Mobile crisis teams and ambulatory detox, requirements of Certified Community Behavioral Health Clinics (CCBHCs), can help to decrease ED visits. Opioid-related emergency department visits are on the rise

Fatal Overdoses in New York Outpace the Nation

New York has consistently had a lower opioid-prescriber rate then the U.S. average, yet has experienced a sharper increase of fatal poisoning by all opioids from 2013 to 2015 that has outpaced the national average.







Medicaid and Medicaid Expansion Are Fighting the Opioid Epidemic

In New York, 60% of patients hospitalized or visiting the emergency room due to opioids have Medicaid coverage, compared to the national average of 40%.

Less than 10% of patients with opioid-related emergency room visits are uninsured, compared with the national average of over 15%. Insurance coverage for opioid-related hospitalizations and ED visits

What Comes Next

While significant progress has been made in increasing access to community based addictions services, through the implementation of Certified Community Behavioral Health Clinics (CCBHC's) and other initiatives, obtaining comprehensive mental health and substance use treatment remains a challenge in New York. Medicaid plays a crucial role in connecting individuals with opioid use disorders to services.

Investment in mental health and addiction treatment and prevention saves money by keeping New Yorkers with mental health and substance use disorders out of emergency rooms, jails and shelters. New Yorkers rely on Medicaid as a source of treatment, and we urge continued preservation of Medicaid funding and services. Significant investments to support additional prevention, treatment & recovery programming statewide are needed to ensure all who seek services can access them when and where they need them.
